## **Total Fees**

The fees are in Australian dollars, and the listed fees include the Goods and Services Tax required to be collected with payments made in Australia

#### **Fees for Public and Corporate Courses**

The decision to hold an advertised public course or a corporate course will be taken at 5PM AEST on the sixth week day before the first day of the course. Cancellations before that time can receive a refund or a credit for any other ALAust course. Cancellations after that time will be entitled only to a credit for any other ALAust course.

A registration can be transferred to a colleague at any time.

Please note that ACCREDITATION involves an agreement with Adair Leadership Development, renewed each year, for continuation of the accreditation status

Organisations can negotiate separate fees for IN-HOUSE and residential programs

ALAust can also CUSTOMIZE workshops and programs to meet the particular needs of individual organizations.

#### Very Early Bird Fees [VEB]

VEB Fees entitle the payer to register for course or courses not yet programmed for a nominated city.

No guarantee is given that a particular course of the nominated type will be offered in that city within a time frame or at all.

If sufficient VEBs are registered for a particular course, it will be held with a minimum six weeks notice to the VEB registrants.

The benefits to ALAust are

- savings in the costs of advertising our courses,
- reduced risks of advertising courses that do not receive sufficient registrants to hold the workshop, or to hold a better workshop
- conduct of workshops with sufficient attendees to maximize the benefits from the group activities
- assistance to our corporate clients in organizing training across parts of their organization (regional, interstate, international)
- securing more workshops with greater numbers of participants from more types of organisations.

The benefits to the VEB registrant are

• a reduced total fee – the VEB will count in full towards the total fee, and the VEB registrant will obtain a **discount** of <u>twice the VEB</u> upon the total fee

- flexibility to apply the VEB in full to other courses, in other cities, or to the benefit of replacements for the nominated course
- the entitlement to repayment of 90% of the VEB on demand anytime up to five days after the date of notice to the VEB registrant of the date of conduct of the nominated course
- the incentive, for other VEB registrants for the nominated course, not to withdraw from the course panel (or the incentive to provide a replacement onto the panel) after the date of notice of the date of conduct of the nominated course

# **FEES for PAPERS & PUBLICATIONS**

Fees will be shown on the ALAust Website against each item, in Australian dollars.

The fee shown will include the Australian Goods and Services Tax

The fee for any hard copy items includes postage within Australia
